### PUBLIC COMMENT – GOOD & WELFARE OF THE COMMUNITY

A resident asked why the Reval was not done previously so that we don't get in this mess again? Our assessed values are too low. Does the town plan to do this every few years going forward? Resident stated that Mike Hartman does not have the time to do this. He also stated that Mr. Hartman is too busy with our town and other towns to do it justice. Resident asked how he will have the time to do fair and accurate assessments. Resident stated that he knows of many residents who don't even bother to get building permits because he doesn't have time to inspect them.

Supervisor Brown stated that the last time we had a reassessment done was 2011. He does not know why it has taken so long to do this again. Supervisor Brown stated that he has spoken with several other Town Supervisors whose towns are not current, nor do they wish to be, because they do not want to stir up the public.

Councilwoman Wittcop stated that five or six years ago, when the market was so high, it would have been a shock for everyone to do a reassessment at that time. The decision was made to let the market come down before doing another reassessment.

Councilman Walker stated that Royalton was going to do an assessment in 2020 when Covid hit, and it was put off. We have a very large town with a lot of square miles and the whole town must be done at the same time. We cannot do one or two areas one year and the rest in another year.

Supervisor Brown stated that the board is aware of the situation and trying to look at the best way to manage this going forward. The resident stated that he is glad to see that it is being discussed. There are many towns that are doing reassessments more frequently to keep the assessed values at 100% all the time. Discussion continued regarding this matter.

There being no further information to come before this board, a motion was made by Councilwoman Wittcop, seconded by Councilman Walker, and carried unanimously that the Regular Board Meeting be adjourned at 7:22 PM.
